The Bank retains the right to set individual fees and charges, other than specified above, for clients, depending on the scope of account transactions and subject to other factors.

¹ Sales tax is 2% of the fee amount according to the applicable legislation of the Kyrgyz Republic.

² Tariffs are specified with taxes according to the applicable legislation of the Kyrgyz Republic.

³ Individual rates may apply in certain cases. In the event of a payment return due to incorrect details provided by the client, the commission charged by the Bank for sending the payment is non-refundable.

⁴The tariff does not apply in the following cases:

- replenishment of an account at the Bishkek branch, the Central branch and the Bishkek-South branch, provided that the account is opened at one of these specified branches;
- replenishment of an account at the Osh branch and the Osh-Datka branch, provided that the account is opened at one of these specified branches.

⁵You can review the list at the bank branches when sending a transfer in US dollars via the SWIFT system. The bank may make changes to the list unilaterally.
