		This Promotion is not a prize lottery. The element of chance is excluded, and no algorithm for random winner selection is applied.

5	How the Promotion Works	<ul> <li>Register in the Kompanion Business application between June 10 and June 30, 2025;</li> <li>Accept payments via QR code or Kompanion Business POS terminal between June 10 and July 10, 2025;</li> <li>Process at least 50 payments via QR or POS terminal through Kompanion Business;</li> <li>Ensure the total amount of QR payments during the promotion period is no less than 50,000 KGS;</li> <li>Only incoming payments of 100 KGS or more are counted toward the Promotion.</li> </ul> All payments that meet the above criteria are automatically entered into the competition.		



6	Procedure for Determining Winners and Prize Distribution	<ul> <li>Three winners will be selected in each branch, as well as at the Head Office of Bank Kompanion.</li> <li>Prizes will be awarded as follows:         <ul> <li>1st place — 50,000 KGS</li> <li>2nd place — 30,000 KGS</li> </ul> </li> <li>Winners will be determined based on the highest number of incoming QR payments received via the POS terminal or the Kompanion Business application during the Promotion period.</li> <li>In the event of a tie in the number of payments, preference will be given to the participant with the higher total payment amount for the Promotion period.</li> <li>The prize will be transferred to the winner's settlement account.</li> <li>In total, up to 57 winners will be selected (3 winners in each of the 19 branches).</li> </ul>
